

# MAVERICKS RV CLUB BY-LAWS

## ARTICLE I NAME

This club, formerly known as the Alfa Mavericks, shall now be called the MAVERICKS RV CLUB and the members shall be called MAVERICKS.

## ARTICLE II PURPOSE

The purpose of the **MAVERICKS RV CLUB** shall be the promotion of good fellowship, fun and companionship among recreational vehicle owners, at regularly scheduled or specially planned gatherings of the MAVERICKS.

## ARTICLE III MEMBERSHIP

- Section 1 Membership to the **MAVERICKS RV CLUB** is open to all RV owners.  
Section 2 They may remain a member as long as they continue to pay dues and wish to participate.  
Section 3 Dues shall be \$10.00 per year. The year shall be from April 1<sup>st</sup> through March 31<sup>st</sup>.  
Section 4 Any member may be dropped from the Club for causing a disturbance, or not complying with park rules when on a campout, or violation of Maverick By-laws, if such actions continue.

## ARTICLE IV OFFICERS

### Section 1 Election of Officers

Officers are to be elected for a 2 year term (with no term limit) as follows: President, Vice-President, Secretary and Treasurer. (President's spouse automatically becomes Secretary and/or Treasurer if he/she desires without further voting, otherwise these offices must be voted upon.) The President shall appoint a Nominating Committee so the election may be held at the last outing of the year. New officers shall assume duties at the first outing of the year.

### Section 2 Duties of Officers

- A. President. The President shall preside over the general membership meetings of the **MAVERICKS RV CLUB**. Succession in the absence of the President shall be: Vice-President, Secretary, Treasurer, and then any past President still an active member of the club.  
B. Vice-President. The Vice-President shall act for the President in his/her absence. The Vice-President shall be responsible for obtaining volunteer Wagonmasters for future outings. The Vice-President may appoint Wagonmasters if no one volunteers.  
C. Secretary. The Secretary shall record the Minutes at all official meetings and enter them into the club records. The Secretary shall also attend to all club correspondence.  
D. Treasurer. The Treasurer shall be responsible for receiving and disbursing club funds at the discretion of the President or a majority vote of the membership present. The Treasurer shall also furnish a financial statement at regular meetings or as directed by the President. He/she shall also be responsible for keeping membership records, notifying members of dues to be paid each year and seeing that a membership roster is kept up to date and presented to all members yearly.  
E. National Board Representatives. We shall maintain Representatives to the Alfa Owners Club as long as they are in effect.

Section 3 Appointive Officers

Appointive Officers of the club will be appointed by the President for any task required.

**ARTICLE V GUESTS**

Section 1 Each chapter member unit may invite guests to attend any outing as long as space is available.

Section 2 Former Mavericks (or Alfa Mavericks) are welcomed guests at any Maverick outing. They may serve as Wagonmaster but cannot serve as an officer without rejoining the Mavericks.

**ARTICLE VI WAGONMASTER’S FUND**

Section 1 The Wagonmasters fund is comprised of registration fees paid to them by members attending each outing. Registration fees are to be used by the Wagonmaster for outing expenses. The Wagonmaster shall complete an accounting of all expenditures. Any funds remaining after these expenses have been paid will be returned to the general fund. If the registration fee does not cover the reasonable cost, the wagonmaster shall present a bill for discussion at the general membership meeting for payment to be approved by the members.

**ARTICLE VII HOLD HARMLESS CLAUSE**

Section 1 The following paragraph will be signed by all persons attending a function:

We agree that we will not hold the **MAVERICKS RV CLUB**, nor any officer, employee or agent of the club, responsible for any personal or property injury of any kind which we or any member of our family may suffer during any outing. This agreement applies regardless of the cause of the injury and includes, without limiting it, whether such injury is caused by a condition of the premises, another club member or any other person. We make this agreement knowingly and recognize that in signing this paper we may be waiving a legal right to recover damages.

**STANDING RULES**

5. Club name tags shall be worn by members when attending outing functions at the outing site.
